- to statutory warranty rights under the applicable national laws which shall not be affected or limited in any way by this Extended Limited Warranty.

d. because the Products\* are eligible for this Extended Limited Warranty and have been purchased, installed and registered by an REC Certified Solar Professional\*.

2. This Extended Limited Warranty includes a 25 Year Product Warranty\*:

The Limited Warranty Certificate as applicable for your Products provides a Product Warranty\*\* which is hereby extended from 20 years from purchase date (not exceeding a maximum period of 20.5 years from production date) to 25 years from installation Date\*; all other conditions of the Product Warranty\*\* remain unchanged.
